



Instructions for Completing the Application for LANtaVan Paratransit Services Senior Shared Ride Lottery Program for People 65+

- ❖ **You must be 65 or older to be eligible for this program.**
- ❖ **LANtaVan services are not free. You will be required to pay a copayment for each trip.**
- ❖ **How to complete and submit the application:**
 1. *Complete the application form*
 - Complete all sections
 - Print clearly using ink pen
 - Do not use pencil
 - Do not highlight any information
 2. *Sign the application form*
 3. *Attach a clear, legible photocopy of one of the following proof of age documents to the application*
 - Photo Motor Vehicle Operator's License
 - Pennsylvania Identification Card (issued by PennDOT)
 - Passport/Naturalization papers
 - Resident Alien Card
 - Birth Certificate
 - Baptismal Certificate
 - PACE ID Card
 - Armed Forces discharge/separation papers
 - Veteran's Universal Access ID Card (date of birth must be on card)
 - Statement of Age from U.S. Social Security Administration
 4. *Submit the application form and proof of age*

 - By e-mail: Submit a .PDF file to LANtaVanApps@lantabus-pa.gov.
 - Applications cannot be submitted by fax
 5. *Applications that are incomplete or illegible will be returned to the APPLICANT. All sections must be completed.*
- ❖ **You will receive your LANtaVan ID card within 21 days from the date we receive your completed application and proof of age document.**
