Why?

- Helps riders, drivers, and business owners plan ahead and know when big changes are coming.
- Prevents major service changes in Winter.
- Gives two clear periods for important rider feedback.
 - Fall Annual Survey
 - Late Winter/Early Spring Annual Service Plan Public Meetings



Why are routes changing again?

These changes are due to a few factors:

- Changes in Whitehall.
 - Whitehall Mall removed access in 2024 & Lehigh Valley Mall Transfer Center will close in June 2025, local bus stop will remain at current location temporarily.

 - Whitehall School District is requesting service to Fullerton
 Changes in shopping habits has affected ridership in Whitehall
 PennDOT projects at US-22 are affecting stops and reliability
 Access to Willow Crest, Parkview, Presidential Village, and Olympic Gardens becoming more difficult due to MacArthur stop access.
- Public Requests. Many Service Changes are due to requests from the public as part of the Annual Survey and Your Voice Initiative feedback.
- **Budget Constraints.** The proposed changes represent a reduction in service overall of about 4% for June. We are starting to make adjustments to the overall service level to put LANTA in the position of being able to address different funding scenarios going forward. It is possible that additional service reductions will be necessary next fiscal year and will depend on the funding situation.

LANTA's Planning department is working hard to limit these changes and mitigate impacts as much as possible.

Service Delivery Changes

LANTA is detangling Service Delivery with Service Types.

Previously, 100, 200, and 300 level services were prevented from operating outside certain service hours.

New Service Standards allow all services to meet rider demands.

Route Classifications affect only stop placement, alignment design, and ADA service areas.



Rapid Transit. Stops only at Named Enhanced Bus Stops.

All Day Service. Monday-Sunday. Direct Service as needed.

Daytime Service. Monday-Saturday. Local Service as needed.

Select Trips as needed.

On-Demand Curb-to-Curb service.

Frequent Local Service as needed.




LANTA is moving away from Cardinal Directions in favor of Destinations.


Eastbound, Westbound, Northbound, and Southbound will be phased out on Maps, Timetables, Apps, and Buses.




Proposed 101 Alignment




Proposed 403 Alignment






Proposed 102 Alignment (No Schedule Change between Cedar Point and Casino)
